**AMENDED ORDER GRANTING FORMER COUNSEL FOR PLAINTIFF'S MOTION
TO RELEASE FUNDS HELD IN COURT REGISTRY**

This matter having come on before the Court and the Court issuing its Order in favor of former counsel for Plaintiff Carmen White (F. Shaun Burns) and F. Shaun Burns being represented by and through his counsel of record, Pool Law Firm, P.C. (Wesley O. Pool), and all other parties having failed to appear or answer otherwise and the Court being well and fully advised in the premises thereof, does therefore find;

1. A Decision Letter was issued in this matter by the Court on April 27, 2009 wherein Plaintiff was awarded her attorney's fees and costs associated with this lawsuit.
2. On August 18, 2009 an Order was entered in the above matter outlining the Court's Decision Letter.
3. On September 25, 2014 F. Shaun Burns former counsel for Plaintiff Carmen White filed a Motion to Release Funds Held in Court Registry to Former Counsel, as Partial Payment of Attorney Fees Awarded After Trial.
4. No answer or response to the Motion was filed by either Plaintiff nor Defendant herein.
5. A Status Conference was set in this matter on June 1st, 2021.
6. Notice of Status Conference was sent to all parties herein by the Court and counsel for F. Shaun Burns mailed a copy of the Notice of Status Conference to Plaintiff Carmen

White.

7. The Status Conference was held on June 1st, 2021 and no one appeared other than counsel for F. Shaun Burns.

Therefore, this Court **ORDERS, ADJUDGES and DECREES** that the Ninth Judicial District Court Clerk, Roosevelt County release to F. Shaun Burns the amount held in the Court's Registry, including accrued interest, in this matter as a partial payment of attorney fees awarded after trial.
